

Policy, legislation, regulation	Are laws made consultatively? Do laws require consultation?	Is government at various levels equipped to consult? Are CSOs and private sector equipped?	Does wide consultation actually happen?
Sector Organisations and Institutions	Are there rules and standards for transparency and ethical behaviour	Is there a clear division of labour and separation of executive and regulatory roles?	Are there directions on promoting regional, gender, ethnic, religious, and sexual equality?

Award of contracts and licences. Regulation and monitoring of operations.	Are there clear and transparent criteria for award?	Are clear and transparent criteria applied?	Are processes open to all interested companies, public and private, domestic and foreign?
Fiscal policy design and administration	Are 'grand' policy issues discussed: investment vs consumption? management of volatility? Is suitable budget information provided?	Arte there the skills in the executive and legislature to deliver a transparent, accessible, comprehensive fiscal policy?	Are there arrangements for resource sharing resources between tiers of government, between regions, between generations?
